NOTIFICATION

Subject:- 2nd tentative select list of candidates against Class-IV posts advertised by this office vide Advt. Notification No. 01/DCA of 2006, dated 06.03.2006.

1. Whereas 56 number of vacancies of Class-IV were advertised by this office vide Advt. Notification No. 01/DCA of 2006, dated 06.03.2006.
2. Whereas against 56 vacancies a list of 49 tentatively selected candidates was notified by this office vide notification No. DCA/Class-IV/5281-85, dated 03.03.2016. The remaining 7 vacancies belong to SC and ALC categories and no candidates are available under these two categories.
3. Whereas tentatively selected candidates were asked to report this office along with original documents within a period of 21 days from the date of publication of the notification.
4. Whereas out of 49 candidates only 18 candidates have reported to this office along with documents possessed by them but documents of only 7 candidates were found as per merit mentioned in the tentative select list.
5. Whereas vide this office notification no. DCA/Class-IV/16/5656-60, dated 15.10.2016 2nd and final chance was provided to those candidates who could not report to this office along with original documents.
6. Whereas in response to the above mentioned notification only two candidates reported to this office within the stipulated time period but the documents of one candidate were not found as per merit mentioned in the tentative select list and another candidate applied for withdrawal of his candidature.
7. Whereas so far documents of only 07 candidates have been found as per the merit mentioned in the tentative select list.
8. Whereas 42 vacancies are available due to non-reporting of candidates and low merit possessed by some candidates selected earlier. The merit of the candidates has been verified as per the documents produced by the tentatively selected candidates.
9. Whereas 2nd tentative select list of 42 candidates annexed to this notification (Open=25; RBA=10;ST=06;SOC=01) has been prepared as per the merit/records available with this office.
10. Whereas the selection criteria stands already published by this office vide notification No. DCA/Class-IV/5281-85, dated 03.03.2016

Now, therefore, the candidates whose details are annexed to this notification are directed to report to this office within a period of 21 days from the date of publication of this notification failing which their candidature shall be cancelled and the candidates who are next in merit shall be selected in their place. After scrutiny of the documents if the merit of any candidate as mentioned in the tentative select list annexed to this notification is found on lower side, his tentative selection shall be deemed as cancelled and he shall be placed in the merit list at an appropriate place as per merit. Any candidate who has applied for the class-IV posts advertised vide above mentioned notification can submit his/her objection/representation against the tentative select list annexed to this notification within a period of 21 days from the date of publication of this notification.
