ADVERTISEMENT NOTICE NO. 01 OF 2018 DATED; 09/04/2018

Applications for direct recruitment to class IV Posts (District Cadre Anantnag) in the Fisheries Department are invited on the prescribed format (Annexure "A") to this Notification. The breakup of vacancies category wise is mentioned in the (Annexure "B").

\*Salary will be made as per SRO 202 of 2015.

Age as on 01-01-2018:

- i. Not below 18 years and
- ii. Not above
  - a) General Category candidate : 40 years
  - b) Physically challenged : 42 years
  - c) SC/ST/OSC/ALC/RBA : 43 years
  - d) Candidates already in Govt Service : 40 years
  - e) Ex- Servicemen : 48 years

I. The candidate who participate in selection process against the posts mentioned below should be the permanent resident of J&K State and:

1. A person shall be deemed to be a resident of the district if he/she has resided in it for a period not less than 15 years before the date of applying for particular posts and is actually residing in the District.
2. If a woman has married in this district, the period of residence of 15 years shall not operate as bar for applying to the posts provided that her husband has resided in this District as the case may be for a period of not less than 15 years.

II. The candidate will have to deposit/submit his/her application form in the Office of the Assistant Director Fisheries Anantnag with exception to the candidates belonging to SC Category. (The SC applicants can deposit their application forms through registered post from any of the districts of J&K State and for rest of the categories including general should be from the native district only).

III. (A) The Educational qualification and physical standards prescribed for the posts of Fisheries Guard/Chowkidar are specified as under:

iii) Written Examination	The question paper will be of 100 marks (Multiple Choice) of two hours duration. (The questions will be of 10 <sup>th</sup> standard)			

**(B). The Educational Qualification for the posts of Safaiwala is specified as:**

Minimum and Maximum qualification shall be Matric and 10+2 respectively from any recognized Board/Institute. The applicants have to undergo written test only.

**(C) The Educational Qualification for the posts of Cook is specified as:**

Minimum and Maximum qualification shall be Matric and 10+2 respectively from any recognized Board/Institute. The applicants have to undergo written test only. Preference would be given to the candidates having **six months certificate course** in concerned discipline from any recognized institute.

**IV. Application Form:**

Application Form (Annexure "A" to this notification) should be duly filled in by the candidate in his/her own hand writing accompanied by two latest passport size photographs (one to be affixed at the space shown in the application form), attested copies of academic qualification, Date of Birth certificate, Marks certificate of each examination passed, Character certificate, category certificate issued by the competent authority in terms of SRO-294, state subject certificate and a demand draft of Rs. 50/- (Rupees Fifty Only) Non-refundable in the name of Assistant Director Fisheries District Anantnag from any branch of J&K Bank payable at J&K Bank TP Anantnag along with the application form before the last date of receipt of applications.

The application form complete in all respects should reach the office of the Assistant Director Fisheries Anantnag by or before **28-04-2018** during office hours.

- V. Selection procedure:** The Selection of the candidates for the post of Fisheries Guard/Chowkidar shall be made on their performance in the physical standard test/written test vis a vis number of vacancies. Except for the post of cook and safaiwala, the selection would be made on the performance of written test only.

**Note:** The appointment shall be in terms of SRO-202 as specified below:

- i) A person appointed shall be initially on probation for a period of five years and after completion of five years his services shall be declared as permanent subject to passing of such tests, or successfully undergoing such training as provided under J&K Civil Services (classification, control and appeal) rules 1956 or as prescribed under the relevant recruitment rules governing the post/service to which he/she has been appointed.
- ii) During the period of five years, the appointee shall be entitled to the minimum of scale of pay along with the grade pay applicable to the post against which he/she is appointed.
- iii) The person appointed against any available vacancy on the basis of being a resident of backward area or an area adjoining Line of Actual control shall serve in such areas for a period of not less than seven years as provided under sub section (2) of Section Reservation Act 2004.
- iv) Every appointee after the completion of five years shall be entitled to fixation of pay in the time scale of pay applicable to the post against which he/she is appointed. The persons appointed shall be entitled to annual increments, Dearness Allowances, House Rent Allowances and City Compensatory Allowances as admissible under rules after successful completion of their five years service on consolidated salary.
- v) These appointees shall be entitled to the benefits under the Medical Attendance Rules and Leave Rules from the date of their appointment.
- vi) The seniority of the appointees under these rules shall reckon from the date of their appointment at appropriate place.
- vii) The period spent on probation/consolidated salary shall also reckon for purposes of calculating the qualifying service of these appointees for pension and other benefits under rules.
