Online applications on the prescribed format are invited from un-employed youth of Rural/Urban areas of Anantnag District who are interested to avail loan facility for establishment of their ventures/units under manufacturing/ service sector(except those on negative list) under Prime Minister's Employment Generation Programme (PMEGP) for the year 2016-17.

KEY SPECIFICATIONS:

- The applicants need to be unemployed/self help groups/registered institutions/co-operative societies. Trusts etc. The applications need to be supported with the following documents :
- Application form, Aadhar Card (Mandatory), Proof of residence.
- Proof of land/ building (copy of sale/rent/lease deed)
- Training/qualification/experience certificate, if any.
- Proper License, if required.
- Project Report
- Affidavit, declaring the fact that the applicant has not availed any subsidy under any central/state subsidy scheme
- The applicants should be not below the age of 18 years.
- The total project cost should not exceed twenty Five (25) lacs in case of manufacturing sector and Ten (10) Lacs in service sector.
- For setting up of projects above five Lacs in service sector and above ten lacs in manufacturing sector, the applicants should have passed 8th.standard.
- The group of industries which could be setup under the scheme, include:
 - a) Mineral, agro and forest based industries (including handmade paper and paper mashie)
 - b) Polymer and chemical based engineering and non conventional energy industries.
 - c) Textile (excluding Khadi)
 - d) Service sector Industries.

The applicants need to fill the online application form on (www.kviconline.gov.in) portal and submit the hard copies of the same in D.I.C. Office Anantnag by or before **15-10-2016**.
